

This guide is to assist you in enrolling in the H&R Block Income Tax Course.



This process is only for **non-HRB associates** or anyone who **does not** have an active Single Sign On (SSO) ID.

H&R Block associates or those with a SSO ID should access Block Academy from DNA to enroll in the *H&R Block Income Tax Course* and upper-level courses.
